Concessions is working on closing out the season. That means:

- **Fire inspection.** Stand has to be inspected once more before we close. Adam's Fire already came out and completed the testing and inspection.
- **Licensing.** We had to renew our town license to continue operating the stand for next season, and all paperwork and fees have been submitted and approved.
- **Inventory**. We will be inventorying and invoicing remaining usable frozen items to baseball, and packaged non-perishables to wrestling.
- **Organizing**. Once we sell off the remaining food items, we'll take time to do some organizing and clean out of unnecessary items in the stand, donate lost and found items, etc. If you have football items in the stand, please be sure to pull them out before the end of next month.
